- Vendors are responsible for leaving the space in the same condition as when the vendor arrived. Oil spills and /or damage to the space must be reported immediately to vendor coordinator.
- All vendors must be set up NO later than 3:30 PM. Vendors are not allowed to move their food truck or bring any vehicle inside the vendor area until crowd clears. Vendors will be notified by staff when it is clear for you to move.
- Vendors are responsible for their own power and water supply.

APPLICANT ACKNOWLEDGEMENT:

Applicant understands the City of Whiteville (hereafter “Festival Organizers”) reserves the right to reject any and all applications. Applicant understands that they are responsible for reading and adhering to all vendor rules and regulations as may be established by the Festival Organizers, as well as any and all applicable local, state, and federal laws and regulations. Applicant hereby agrees to indemnify, hold harmless, and release the City of Whiteville, and the Festival Organizers and any or all sponsors or agents from any loss, liability, damage, or costs (including attorney fees and court costs) and any and all claims of injury or damages resulting from and/or arising out of their participation in the Downtown Whiteville Christmas Extravaganza, whether caused by negligence or willful act of the Applicant or any other person.
